## **BROKER OF RECORD CHANGES**

## **Group Broker of Record (BOR) Changes**

If a prospective client, who currently has an in-force policy, would like to make you their broker of record, they can do so by writing a Broker of Record (BOR) letter to the carrier. Here is a <u>Sample group BOR letter</u>

- The letter must be written on the company letterhead and signed by an authorized purchaser
- The producer must be licensed with the carrier
- Processing time can be anywhere from a few days to as long as a month, depending on the time of year
- Aetna & UHC effective date will the 1<sup>st</sup> day of the month following receipt of the BOR
  - Aetna & UHC will not allow FLEX to be the GA OR service a group that was not written through our agency. Please send your BOR letter directly to the carrier.
  - Aetna BORs send to: brokercomm@aetna.com
  - UHC BORs send to: agtcomp@uhc.com
  - ➤ UHC ALL-Savers BORs send to: <u>L&CAllSavers@UnitedHealthone.com</u>
- BCBSIL and BCBSTX will accept BOR letters up to the 5<sup>th</sup> day of each month
  - Example: broker has until 6/5/17 to turn in a BOR effective retroactively to 6/1/17
  - If more than one broker should be named on the account and there is to be a split commission, all producers' names must be listed in the letter
  - BCBS has a split commission form that must also be completed. It is called the <u>Amendment to HCSC</u>
    Standard Producer Agreement: Individual Case Agreement
    - Each broker must complete their own form
      - ➤ BCBS BORs send to: Producer\_Service\_Center@hcsc.net, and cc: GAservice@flexiblebenefit.com or TXservice@flexiblebenefit.com
- Dearborn National effective date will be based on the paid-to-date of the group
  - If the client has both BCBS and Dearborn National coverage, both BOR requests can be made in one letter
