According to the Affordable Care Act (ACA), individuals need to have health insurance coverage by March 31, 2014, in order to avoid government tax penalties. In 2014, a family that fails to get insurance will have to pay 1 percent of their income or \$95 per adult and \$47.50 per child—whichever is greater. The penalties will increase to 2 percent in 2015 and 2.5 percent in 2016.
